The minutes of the November meeting were proposed by Jean Miller and seconded by Tom Stevenson.

**Shirley** introduced Geoff Milnes as our new Treasurer and he gave us a resumé of his career as a bank manager.

Shirley then also introduced Nick Winter as the new Groups Coordinator. He said that Elizabeth would be a hard act to follow but that he would have help from the new team, Jenny, Jean and Krystina..

A new Communications Officer is still needed, offers to Shirley please.

Shirley apologised for the fact that the Newsletter had omitted to say who our speaker was for to-day.

She then gave a big thanks to Karen, Marie and Angela for organising the Valentine Ball.

Shirley also thanked our new Publicity Officer, Tom Miller who had taken photos at the Ball which would appear in the next edition of the Costa Blanca News.

Thanks also went to Ken Robinson in his absence for auditing our accounts. He will receive some wine as a token of our thanks.

Sally Wells was given a tin of chocolates as a thank you for arranging the popular Christmas Follies. Sam took the chocolates for her as Sally was away.

The new-look Newsletter will be launched in April and thanks go to Wilma Stevenson and Sue Bentley for their hard work in bringing this to fruition.

**Paul Pruden** gave a short resumé of his new group, Friends of Avinença, which is not a closed group but open to all members and not a travel group either. There will be day trips with English speaking guides at places not usually open to the public where members can learn about the history and culture of the area.

Shirley continued with an up-date of our fund raising for Xabia Bella. She hopes the Director will be able to come to our next meeting to collect a cheque of money raised from the individual events taking place in people's homes. So far, 960€ have been raised from four events. A group from the Committee had been to the Centre to deliver Christmas presents; many of the young people there have no family to give them presents or to take them out so we were also able to provide funds for visits. Anne Bickerstaff, one of our newer members, has made a beautiful patchwork cushion which Shirley showed. This will be raffled at a forthcoming coffee morning at Diane Orde's.

Shirley said this year was the first time members would be voting at our AGM. As it is not possible, due to room size, for all members to attend ballot papers were available to-

day for members to cast their vote or they could vote via e-mail. If anyone knows of a member without email who cannot attend the meeting they should contact a member of the Committee who will make arrangements for them to vote. Sam Wells and Wilma Stevenson will be the only ones doing the count so privacy will be maintained. Shirley reminded members that the committee has the power to co-opt a member if necessary.

Re: the Statutes, Paul has rewritten these after discussion with Shirley, there being no fundamental changes, the biggest being the restructure of the Committee. This was due to the large increase in members which put a much bigger workload on the Committee. 35 new members had joined to-day. There was no succession plan for the Committee. With the increase in membership came an increase in the number of groups which made the role of Group Coordinator much more difficult. With such a large committee it made decision making more lengthy. With 16 committee members in the new structure the load will be spread and with only 7 of these positions being executive, meetings should be more effective and the deputies will be part of the succession plan. It is very important that members vote on this issue as we need 50% minimum in order that the changes can take place.

Shirley asked if there were any questions about this and one member asked if the statutes could be put on the web but Shirley said she was not prepared to risk having lots of changes to make with different ideas coming in. John Chun asked how many had actually read the statutes. Paul said that at the Open meeting in January when he had them all displayed by his table only two people had stopped to read them. Shirley said she was prepared to sit down and discuss them with anyone. Once approved at the AGM they will be printed on the web in both English and Spanish. Lots of people have enjoyed the individual charity events and would like to do more. Also, there could be the possibility of fun events, not for charity. Finally, Shirley announced some new discounts on offer to U3A members, namely: 5 Star Pool Cleaning Service, Joyce Nail Salon, Tracey Baker Holistic Therapy, and Gilly McNally Sports Therapist. Details of these can be found on the webpage.

**Paul** spoke briefly about our charity, Xabia Bella saying that details about the different events taking place could be seen on the web. Several individual events had already taken place successfully with more to come over the next few weeks. He said that sponsors were needed for Keith Cottingham who was due to walk for the charity and that there would be a bucket for donations in the foyer after the meeting.

Geoff reported that funds were healthy with 13269€ being available and that we were well within budget.

Wilma said that over 80% of members had renewed in January with 200 still left to pay. She thanked all those who had volunteered to help at January's meeting. .By the AGM there will be no Associate members, the current 56 will have been made up to full members. There are about 100 members without emails and some will not disclose their email addresses or telephone numbers and Wilma asked if anyone knew anyone in this category please to tell them that all are now full members and entitled to attend meetings. With the 35 new members of to-day membership now stands at 1105. If those who have not renewed their membership do not do so they will be deleted from the list at the end of the month.

Members'Insurance 1700€ Stationery etc. 600€ Miscellaneous 1800€

For 2011 Geoff has budgeted 13000€, up 500€ from last year as he has calculated for 500€ to be available for groups, to be allocated at the discretion of John Bellinger-Smith the Groups' Coordinator.

**Wilma** announced that at last month's Open Meeting we had 87 new members and a further 21 to-day with 41 more renewals. 220 have not renewed for this year so will be deleted from the list to-day which will reduce the number of members to just under 1000 from to-day's 1200.

Carol has instigated a "Group of the Month" in each News Letter. John will coordinate each article with the relevant information. They both invited members to send in suggestions for inclusion in the Newsletter. Carol reported how hard Sam Wells was working on the development of the web-site. Also Tom Miller, as Publicity Officer, continues to work hard with the local press and if anyone wants publicity for their activities then they should contact either Carol or Tom. A new item in the News Letter is a monthly programme of what's happening in Javea. There is a link on the web-site to this official Javea enterprise. Members have already suggested how useful it is.

**John** thanked the Group Leaders who worked so hard to make our U3A such a success. This met with a spontaneous round of applause for the Group Leaders. 5 groups have had to close, 2 of which were sailing as their access to the water had been closed. Others were using your i-pod, post-card collecting and patchworking. John thanked the outgoing leaders. Other groups have had a change of leader, these being:

The latest group starting up is a second Art for Beginners, Sandy being the new leader.. Details will be on the web-site soon, which will also include a suggestion for the formation of a Line Dancing group for Beginners. Play Reading has some hopeful members but a leader is still needed. The car treasure hunt was a great success with 60 members partaking. John himself is now the leader for that activity. Patchworking will restart on March 3<sup>rd</sup> at 3pm. A new Scrabble group for ordinary level players is also in the pipe-line.

Accommodation for some groups is an ongoing investigation.

**Paul** announced that ticket sales for the forthcoming May Ball are now at 267. He will now offer them to other local U3As. We would like to sell over 300, maximum 350. Paul then gave some information on behalf of MABS. There is a Race for Life sponsored event on 3<sup>rd</sup> April from Sol Park in Moraira, entry fee 10€ On 16<sup>th</sup> April there will be a Book Sale outside Iceland starting at 10.00am.

Paul thanked Ken Robinson for auditing the accounts for 2010. Pat received some wine on his behalf.

**Sam** reported that lots of things were going on with the website. The discounts will soon appear in table form which will make it easier for all.

**Shirley** announced that during the coming week-end the almond blossom would be at its best, especially in the Jalon valley.

She then introduced this month's speaker, Stephen Ashley of the Costa Blanca Samaritans. The meeting concluded with questions from the floor after which Shirley presented him with a cheque for 100€.

**Shirley** started the Meeting by asking for last month's minutes to be agreed on. These were proposed by Gerald Dobson and seconded by Peter Speers.

Shirley informed the members of the next production of the Javea Players, this being "Holiday Snap". Also, the Moraira/Teulada U3A are holding a Ball in September and the Pego and Val de Pop are holding one on May 28<sup>th</sup>, both of which are open to Javea U3A.

As the Director of Xabia Bella, who was due to come and collect a cheque, was delayed Shirley decided to continue with the AGM. She delivered the President's Report which is to be found in full in the Newsletter and recorded in the Minutes Book.

The Director of Xabia Bella, Raül Pastor Serra, arrived and after Shirley had introduced him he gave a short talk about the work that goes on at the Centre and how grateful everyone was for the gifts and help they have received from the U3A. Shirley presented him with a certificate showing we had raised for them over 3000€. Raül will consult with Shirley and Paul about how it is used.

Paul then delivered the Vice President's Report in which he mentioned raising 1820€ for the Alzheimers Centre from the raffle at February's Ball and 5720€ altogether this year to charitable and worthy causes in the Javea area.

He discussed the revision of the Statutes, stressing how important it had been to do. The main changes had been the way we convene and call for a General Meeting of the Assembly, the composition of the Representative body, that is the Committee and job descriptions for the key executive members of the Committee. He thanked everyone for their efforts.

**Geoff** gave a "Layman's Guide to Java U3A's Accounts", using a Power Point presentation which made it all more interesting and understandable. This can also be found on the web site.

Wilma gave a run down of the membership for the past year during which we had done away with Associate members and now everyone is a Full Member. There are currently 966 members although less than 20% attend meetings. Wilma has been able to make use of the statistical recording, for instance, knowing how many members join groups or lead them.

As Nick Winter has only recently taken over as Groups' Coordinator **Elizabeth Collins** gave a brief summary of the activities of the past year.

**Shirley** then presented Sue Bentley with a bouquet of flowers and Sam with some wine as a thank you for their hard work as they step down from the Executive Committee. Karen, Jean and Mick were not present so they will receive theirs next month.

Voting then took place for changes to the Committee Structure, changes to the Statutes and acceptance of the 2009 Accounts. These were passed with 89.6%, 91.9% and 94.5% respectively. The vast majority of these votes had taken place previously via emails or at the February Meeting as was the election of officers to the Committee for 2010/2011. The results will appear in the Newsletter and recorded in the Minutes Book.

Shirley outlined the Committee Objectives for 2010/2011, which were principally accommodation, the new structure and job descriptions and the Committee vacancy for a Communications Officer. She then introduced Peter Speers who had volunteered as the Events Organiser, who will be helped by various members of the Committee as the need arises.

Paul outlined the objectives for charities in 2010/2011 and gave a list of speakers for the monthly meetings,

**Sue and Wilma** used a Power Point presentation to show the members the new format of the Newsletter. This was very well received.

Nick thanked Elizabeth for her hard work as the previous Groups' Coordinator and for her good and helpful handover. He informed everyone of two new groups being looked at, these being Tai Chi and Ballroom Dancing. He asked anyone interested in helping to contact him to see if they may be feasible. He said that the Moraira/Teulada U3A had invited any Javea members interested in joining their choir to contact them, but we operate a policy of no joint groups.

Nick said there would be a Meeting for all Group leaders in April or May and in June the monthly meeting would take the form of an Open Meeting with groups demonstrating their work.

**Peter Sanders** spoke briefly about a new group he wished to start, namely SLR for beginners and asked anyone interested to see him afterwards.

**Shirley** asked for any questions from the floor but there were none.

Everyone was then asked to feel under their chair and the lucky ones found an envelope entitling them to an Easter egg. This made a fun end to the meeting and AGM.

It was extremely sad to lose Elizabeth as Groups Co-ordinator but with her move back to Pego and Steve taking on a more active role in the Costa Blanca Wine Society it became impossible for her to continue. Our thanks go to Elizabeth for the tremendous work she has done over the last couple of years, but I am pleased to say that a volunteer not to be daunted by the task of following in Elizabeth's footsteps, did come forward and hopefully today Nick will be elected to the Committee.

During the last year the number of groups has grown enormously and continues to do so with another 4/5 in the background about to be launched. In a few minutes Elizabeth will give us a review of the Groups Activity for the year and later on Nick will give us some ideas for this year.

Due to a few problems and misunderstandings at the beginning of last year it became necessary to update the Travel/Events/Activities Policy. This was undertaken by a couple of members of the Committee and the Travel Group. It was circulated to all Group Leaders and Members in September. In the next month this will be published On the Website.

### **Accounts**

Under the expert hands of Marie our accounts were kept in good order and were audited by Ken Robinson with no problems. These were published and sent out to members at the end of February.

Marie decided to step down as the Treasurer and we would like to extend our thanks to her for the work that she has done on the Accounts.

Sue has worked extremely hard this year preparing the newsletter – did you know it takes approximately six hours to prepare the newsletter which gets longer and longer, so Sue and Wilma have been working on a new format which they shall present to you later on that will be much shorter and contain only new information. We shall be encouraging Group Leaders to use their pages on the Website for day to day information.

#### Website

Over the year Sam has worked many a day and night revamping the Website and what a fantastic job he has done, if you have not looked at it then pleased do, it tells you all you would like to know about our Society and activities. You are only ever a few clicks away from any information you may need. If you are one of the Health Walkers, and the weather looks a bit dodgy, a simple click on the mouse will let you know if a walk has been changed or cancelled. Well done to Clive and Karen for assisting Sam with the development of the Group Pages especially the Walking one, have a look for yourselves, the new website is brilliant. Our thanks go to Sam Wells, Clive White and John Wild for enabling these changes to happen. If you have not been on the website recently we would urge you to take a look.

#### **Travel and Social Activities**

Due to the downturn in the economy several trips had to be cancelled, as a result the Travel Group reviewed its activities, and I am pleased to say once again many trips are full with a waiting list. Wilma also said things were quiet. 999 members with an extra 14 joining to-day to bring the total to 1013, coming from 18 different locales.

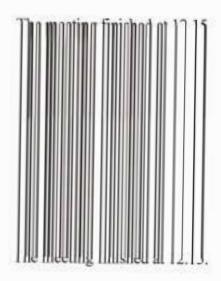

Shirley announced that she is standing down as President, also Sue Bentley as Deputy Secretary, Nick Winter, due to family problems who would like to leave as soon as a replacement can be found for Groups Coordinator, and Jeni Oldfield as Secretary. If anyone feels they can fill any of these roles then will they please contact Shirley.

**Geoff** told us the funds are around 2400€ and that we are operating inside budget. There are no plans to implement a reduction in subscriptions as group accommodation and equipment may need funds.

Wilma informed us that membership in June stood at 1022 and with 28 new members to-day that number is now 1050. In the next two months members who are unable to attend in January to pay will be able do so at those two meetings.

**Nick** said that Jill Birch has set up a Discussion Group, with subjects such as "Should religious laws take precedence over state laws" as a taster.

Javea Bowls Club has offered their facilities to Javea U3A members; Moraira U3A already do so and it was wondered if Javea would like to form a similar group. The fee would be 8€ per player, a reduction on the normal fee and no need to become a member. Anyone interested should contact Nick.

**Shirley** reminded everyone that she is still looking for suitable accommodation for groups to meet.

She exhorted all to come to November's meeting which promised even better entertainment than last year – if that is possible.

Tom Miller, our Publicity Officer, will publicise any group activity if he is given relevant information.

There is information on the notice board about a talk in the Art Centre at Vilajoyosa. They are trying to raise funds for a disabled boy to take part in the Tall Ships Race.

**Paul Pruden** gave a short talk about the Friends of Avinenca. There is an important meeting at La Senieta in Moraira on November 2<sup>nd</sup> at 10.00 about the wetlands behind Apolla beach in Moraira.

**Cheda** gave a talk on his experiences as a Blue Badge Guide in London which was very entertaining.

The meeting ended at 12.00.

**Shirley** opened the meeting by welcoming members and asking for proposers and seconders for the *minutes of the May and September monthly meetings*. Cheda Panatajovski proposed and Joanne O'Keefe seconded the May minutes. Jean Miller proposed and Betty Guiness seconded the September minutes.

Shirley then welcomed John Bellinger-Smith as the *new Groups Coordinator*, adding that the committee had voted unanimously in approving his appointment, and that formal election to post will take place at the March AGM. Members were asked to give John a warm welcome. Shirley noted that the last 2 committee positions of Communications Officer and Groups Coordinator had both been filled by relatively new members to the U3A.

**John** introduced himself and gave a brief resume of his past careers in the RAF and in the computer industry.

**Shirley** continued with an *update on the progress of the approval of the Statutes*. The Gestor is confident that there will be no problem in getting approval, however, the Alicante authority has such a backlog, that it is likely to be at least a year before formal approval of the Statutes is granted. In the meantime, a *special certificate has been issued* to allow us to change bank accounts, and subsequently introduce direct debit arrangements for membership fees. Sam will put the *uncertified version* of the Statutes on the U3A website tonight, in both English and Spanish, for members to read.

Re: the March 2011 AGM, Shirley said that the *method of voting was to be reviewed*. On a show of hands from members, nobody was against the system of electronic voting used last year, however, Shirley noted there was a need for new people to step forward for *committee positions for next year*:

A *new President* was needed as Shirley would be stepping down, and Paul was reluctant to take over due to other commitments.

A new Secretary was needed as Jeni Oldfield would be stepping down.

A new Deputy Secretary was needed as Sue Bentley would be stepping down.

Shirley noted that today was the first time that a full committee was in place.

Re: accommodation, Shirley reported on the considerable problems experienced by Group Leaders, especially at the Social Centre where groups were frequently moved out of booked rooms. Rental is costly and premises are few and far between. Group Leaders will be consulted on their needs on Monday at the Group Leaders' meeting, and there will be a report back at next month's Parador meeting. Shirley made a request from members for any information regarding possible premises. It was noted that L'Ancora Tennis Club had opened up some rooms and one was already being used by a Computer group.

Re: *Charities supported*, Shirley assured members that Xabia Bella have not closed down, and were not intending to close down. Money has not been handed over to them. Instead, money is kept in an account for when it is needed for Residents' trips out etc.

Brenda Bates noted that €40, raised from the Book Swap table at the monthly meetings, had been given over for our Charities.

Shirley noted that events earlier in the year in support of our current charity, CARITAS, had raised over €1000. The Recession had meant that many groups were struggling to feed themselves, and Shirley appealed for new fund raising events, referring members to Peter Speer, Events Organiser.

Shirley *publicised the sale of tickets for the raffle that will be held at the November meeting.* First prize has been donated by the Patchwork group, and Second prize will be a book written by a previous speaker, Kathryn Marsden.

Next month, there will be a box to receive *donations of food* outside the meeting hall. CARITAS will collect and distribute the food.

Shirley noted that *next month's meeting* will be longer than usual as there is a lot lined up, including some fun things. Angela Chantry will be outlining next year's Travel programme, Shirley will be giving a review of the year, and plans for next year, and Paul will be in charge of entertainment.

Shirley announced the *next May Ball* which is to be held on May 6<sup>th</sup>. Tickets will be on sale at the January meeting.

Shirley also publicised an event in Gata on 13<sup>th</sup> November, which is being held in support of Emaus, the children's charity.

**Paul** gave an *update following the meeting of area U3A associations* last month. Two main items had been covered:

- a) Travel it had been decided to open up trips to members of other U3A organisations, if trips looked like they might not be viable following insufficient take-up from the particular organisation's own members. This had necessitated setting up Guidelines for Travel representatives re allocation of places, collection of money etc. These have been circulated and approval has been gained from many of the organisations.
- b) Third Party insurance A blanket policy is being considered to cover all U3A organisations. This has also been circulated and many favourable responses received eg from Torreviecha. The benefits of a joint policy are reduced costs and the knowledge that everyone is covered, smoothing the way for joint trips and activities.

Paul mentioned an initiative suggested by Sally Skelton in the Ayuntamiento involving *members singing carols in the Pueblo*, along with those of other nationalities (Spanish, German, French, Dutch etc). Paul is attending a meeting next week to arrange times and dates, and asked for members, interested in participating, to come forward.

Geoff noted that *current total funds* stood at €19,447 – being made up of funds of €18,997 plus a petty cash amount of €450. Once subscriptions, travel costs, charity donations, and budget expenditure for the rest of the year have been allowed for, the amount reduces to €6257. This amount, however, does not allow for 25% depreciation of equipment and any unexpected costs or liabilities eg renting accommodation for Group leaders.

Re: Xabia Bella, Geoff noted that funds had been donated to cover specific areas:-

- 1) A special electronic mattress used by residents to keep limbs mobile (approx €400)
- 2) Special outings to Valencia: a Safari trip

An amount of €1800 remained which will be used into next year. Geoff assured members that manager Raoul was still actively in charge and trying to maintain the quality of life for residents.

Wilma noted that 22 new members had joined this morning, and 38 members had prepaid subscriptions for next year. This gave a *total membership of 1078 persons*.

Carol gave thanks to everyone for helping her settle in to her new position, specifically mentioning Shirley, Paul, Sam, and Tom and Jean Miller. She added that the *November Newsletter* would be totally her responsibility and that she had set up a specific email address for this. The cut off date for contributions to the Newsletter would be 18<sup>th</sup> November, and copies of any items should also be sent to Sam. Carol said she was wanting to encourage items from Group Leaders not usually heard from, and wanted the website to be as up to date and current as

possible. She directed Group Leaders to get in touch with Tom Miller if they had any items to go into the local press, and invited approaches from members to get in touch with her.

**John** reported that he had *liaised with Sally Skelton* over the accommodation problems, and was *planning to get in touch with all Group leaders* and attend groups over the next few weeks. John publicised the Tuesday lecture on 2<sup>nd</sup> November which was on the subject of Van Gogh. He reported that the *Pet Sitting* circle was now in place, and was meeting next week regarding the rules and regulations to be applied.

New groups - John announced the start of a new group – the Beginners Health Walks. Shirley added that she would be running them for 6 weeks, after which participants could join the Monday Health walks if they were fit enough. It was hoped to start a Car Treasure Hunt group by December – these would be planned monthly; they would start at 10.30 am and end with lunch. A new group focusing on people wanting to write a book was to be started by a professional writer. It was pointed out that this was not a creative writing group but a support group.

There was a *potential Group Leader* for a Badminton group, and interested members were asked to let John know. There was also a potential leader for an Acrylic painting group. *Other new groups planned* included – Tai Chi, Ten pin Bowling, Line dancing and a Play reading group. Group leaders were needed for these groups.

Re: companies delivering from the UK – John reported that Jean Miller had been collating information into lists of organisations who delivered to Spain/ collected from Spain/ ran depots in Spain.

**Shirley** made the following *final comments* – a reminder to members to look at the notice boards; a report that the crockery bought on behalf of the organisation was already being used – the Solos group had borrowed it last week; and Lin Jones will be selling calendars in aid of MABS.

In answer to a question concerning the raffle, Shirley confirmed that the raffle will take place at the November meeting and will include any tickets sold this month.

Finally, she requested that any members not staying for the speaker should leave.

**Shirley** *introduced the speaker*, *Robert Vandevelde* who gave a very interesting talk on acupuncture and Chinese medicine.

Following questions to the speaker, the meeting concluded at 12.40 pm.
