1 Welcome & Apologies

VD welcomed everyone to the meeting. She explained that David Whybrow was unable to attend the meeting because he had been admitted to hospital and said we all wished him a speedy recovery.

2 Approval of October General Meeting Minutes

3 Presidents Report & Announcements

VD announced that Krystyna Stefanczyk Deputy Groups Coordinator would act on David's behalf whilst he is unwell.

The AGM is next month and members **must** bring their membership cards to be admitted to the meeting.

VD presented a cheque for 2189,26€ for the total amount raised from various events and renting of crockery during 2019 to Help of Denia. Of this 232€ was raised from the collecting tins available at every monthly meeting and within that 117€ raised by VD herself from selling cakes, pies and jams. This was marked by a round of applause.

Vice President of Help of Denia and U3A Jávea member Catherine Perez-Pinto thanked members for such a generous donation saying that these donations go towards projects such as providing toys and other playthings in the children's waiting area of the hospital where they had also installed a large dragon which they could climb on.

Catherine introduced another U3A Jávea member Philip Bowick as the new Treasurer for the organisation. He reiterated her thanks for the generosity of members.

VD announced that this year's charity would be Make a Smile and invited Tony Grande from the charity to tell us more about it. Tony runs the Bed Centre, Calpe and he is one of the founder members of Make a Smile whose aim is 'To supply daily needs for 50 children in the Emaus group and a home with 24 mentally handicapped youngsters. To help make these youngsters self-sufficient'.

The self-sufficiency project at the Relleu Home allows the mentally handicapped children to grow their own vegetables and keep chickens whilst providing occupational therapy for them.

Tony expressed much appreciation on behalf of Make a Smile that U3A Jávea would be raising funds for them this year.

Collecting tins will be available at each monthly meeting and there will be fund raising at U3A Jávea events throughout the year.
